## 2024 Election Priorities

### Investment in Infrastructure

County Kildare's strategic location within the mid-east region and its proximity to Dublin make it an ideal location for business development. However, addressing capacity issues with water and electricity is crucial. Investments in water, wastewater, and grid connectivity are vital for the county to continue to function, grow, and attract more businesses. Enhanced infrastructure, including reliable utilities, will unlock Kildare's potential, making the county more competitive and attractive to investors.

Prioritising the enhancement of water and grid infrastructure through projects led by Irish Water and Eirgrid, is crucial to support the county's growing population and business needs. These improvements will ensure the sustainability of business operations and improve the quality of life for residents. Compared to other areas within the mid-east region, Kildare has a large capacity for development, with ample space for potential development.

Addressing these infrastructure needs will position Kildare as a prime destination for economic activities.

### **Transportation Enhancements**

Continued support and prioritisation for the Dart+ South and West projects are essential. The electrification of the rail network to Kilcock, Newbridge and Kildare Town is vital for enhancing connectivity within the county. Improved rail services will facilitate easier commuting, reduce traffic congestion, and promote sustainable travel options. This investment not only benefits residents but also makes Kildare a more appealing location for businesses looking for efficient transport links.

Enhancing transportation infrastructure is crucial for the long-term growth and development of Kildare. By investing and prioritising projects like Dart+ South and West, the county can ensure that its transport network meets the needs of both businesses and residents. Improved connectivity will attract more businesses to the area, create job opportunities, and support sustainable economic growth. This strategic investment will also help reduce the county's carbon footprint by promoting public transportation over private car use.

## **Education & Skills Development**

A well-educated and skilled workforce is vital for economic growth. Improve access to and increase funding for early learning schemes, such as the Early Childhood Care & Education programme and the expansion of breakfast clubs and afterschool childcare programmes. Expand mentoring programmes, like "Better Start", that focuses on improving the quality of childcare and early education.

This commitment to education will attract businesses looking for a skilled labour pool and contribute to the overall economic development of the county.

## **Land Zoning & Public Transport**

Land zoning for housing and its linkage to better public transport facilities are critical, especially in urban centres like Naas, Newbridge, and Maynooth. Properly planned housing development, coupled with improved public transport, will support population growth and ensure sustainable urbanisation.

This approach will enhance the quality of life for residents and make Kildare more attractive to new businesses and residents alike.

By focusing on strategic land zoning and public transport enhancements, Kildare can address housing needs while promoting efficient and sustainable urban development. Delivering affordable housing is critical to the future success of Kildare, and should be a priority for the next Government. We ask that at least 15,000 housing units are built within the Kildare commuter areas of the GDA.

This integrated approach will help reduce traffic congestion, lower emissions, and create vibrant, liveable communities. Investments in public transport infrastructure will also ensure that residents have access to reliable and convenient transportation options, supporting the county's growth and development.

### **SMEs and Diversified Economy**

Support also needs to be given to Local Authorities to grow regional innovation hubs and to support domestic enterprise. Ireland needs to continue to expand on the provision of upskilling grants for SME's, enabling small businesses to support continued workforce development.

Sustainable development practices will not only benefit the environment but also enhance Kildare's attractiveness to ecoconscious investors and consumers. Our lack of renewable energy infrastructure and restrictive regulation, has meant that investment and growth opportunities for domestic and FDI clients across the County and the region, has been effectively removed.

This approach will ensure that Kildare's growth is both economically and environmentally sustainable, securing a prosperous future for the county.

## Sustainable Development

Promoting sustainable development is key to ensuring long-term economic prosperity. Ireland can look at unique initiatives from other countries, such as the Dutch circular economy model, which focuses on resource efficiency and waste reduction.
